## **Historical and Biographical Notes**

In 1931, The State Building Aid law allowed rural school districts, composed of two more or combined districts or an enlarged district, that constructed a new school building to be paid \$1000 for each old building abandoned (*Laws 1931*, p. 346).

The law was amended in 1963. The amendment removed enlarged districts and required a combined elementary building in order for a district to qualify. (*Laws 1963*, p. 200). The law was repealed in 1973 as part of a larger education bill (*Laws 1973*, p. 230).
