Abstract: Records of the Board of the Permanent Seat of Government, the organization that sold lots in Jefferson City, including plat indexes, minutes, contracts, ledger books, and correspondence, 1821-1939 (bulk dates, 1823-1870).

Historical and Biographical Notes

The Board of the Permanent Seat of Government was created via Article XI of the original 1820 Missouri Constitution (p. 23, handwritten original). The original board consisted of five commissioners appointed by the General Assembly at its first session. One commissioner was to be chosen from each corner of the state, plus one from the center. The goal was to examine four sections of land that was not yet sold to the public

for the site of the new Missouri Capitol. The site was to be along the banks of the Missouri River within forty miles of the Osage River. The two sites under strongest consideration were the location of Jefferson City, and Côte Sans Deissein (on the river southwest of Tebbetts in Callaway County). Once the site was selected, the board was to plat a town on the land, select the location of the permanent seat of government and erect a structure no later than the first day of October, 1826. The board would also be in charge of selling lots to citizens moving to the new capital.

The Board would continue its original purpose during the early years of state government, but that mission would change in 1855. Chapter XXVII of the Revised Missouri Statues restructured the board to have a Commissioner of the Permanent Seat of Government elected by vote of the General Assembly at its first meeting of the session (1855 RSMo, p. 340). The commissioner would be in charge of selling government-owned lots in Jefferson City and be the caretaker for state government buildings, including overseeing repairs, furnishing offices, and cleaning of structures.

The board was restructured again in 1877. Senate Bill 4, appointed the governor, secretary of state, state auditor, state treasurer, and the attorney general to the board (*Laws* 1877, p. 322). The board would oversee state property. The Commissioner of the Permanent State of Government role become that of the property manager, but would now be appointed by the Board. In 1919, Senate Bill 469 updated the commissioner's duties to include the ability to employ laborers (*Laws* 1919, p. 217).

The Board of the Permanent Seat of Government was abolished in 1945 via Senate Bill 297 and its duties, along with those of the State Building Commission, were transferred to the Board of Public Buildings (*Laws* 1945, p. 1428).

1919	The Commissioner's duties were updated by Senate Bill 469, approved on May 29, to include the ability to employ laborers, effective October 5.

Scope and Content

The Certificates and Letters for Lots Sold in the City of Jefferson series contains land sale certificates and letters regarding land sales in the state capitol from 1823 through the 1860s. The majority are from 1823 through 1855. Certificates are organized by purchaser's last name. Letters are organized by the sender's last name. Original order of certificates and letters interfiled was maintained.

The original state-held copies were lost in the 1837 Capitol fire. These records are the copies required to be filed in the Surveyor General's office in St. Louis. They were transferred to Jefferson City in 1874.

The Miscellaneous folder contains mixed alphabetized lists of lots sold, several accounting pages, and one plat map.
