Historical and Biographical Notes

The territorial general assembly passed *An Act concerning public Roads and Highways*, which allowed for inhabitants of a district (predecessors of counties) to petition for public roads within a district in 1806 (*Laws*, Volume 1, p. 86). The territorial general assembly ordered the first cross district public road, a road from St. Louis to New Madrid in 1808 (*Laws*, Volume 1, p. 188). For each road the legislature appointed three commissioners who were to provide a report to the governor. Once approved by the governor, the plats were to be filed with the clerks of the courts of quarter sessions in each district (*Laws*, Volume 1, p. 225), and the road declared a public road. The second public road, from Potosi to Boon's Lick, was ordered in 1816 (*Laws*, Volume 1, p. 479).

An 1814 act (*Laws*, volume 1, p. 323), declared all roads in the counties "laid out by order of court according to law" to be public roads and further set requirements for the roads including size, twenty feet wide with no stump to "exceed twelve inches in height." Later laws amended this act, allowing roads to be between 60 feet and 20 feet wide.

In 1827 the General Assembly passed *An Act establishing the State Roads therein mentioned* (*Laws*, Volume 2, p. 136). This declared roads previously "made under the authority of the State" were public highways and set the manner in which new roads or changes were to be created and records filed. The act allowed inhabitants of a county to petition for changes to the state road within their county, in addition to state roads created by acts of the General Assembly.

Three commissioners were appointed for all survey's or resurvey's and copies of the surveys were to be provided by the commissioners to the county courts and the Governor for the general assembly.

An Act to establish a State road from Columbia, in Boone county, via Rocheport, to Boonville, Cooper county, in 1833 (*Laws*, Volume 2, p. 386), is the first road where the commissioners were required to submit their surveys to the Secretary of State instead of the governor.

The 1839 *An Act to prescribe the manner of opening State Roads* (*Laws*, 1839, p. 105) formalized procedures for the creation of state roads. Roads were still to be declared state roads by act of the General Assembly, and three commissioners would be appointed based on the respective acts. The Commissioners were to appoint the surveyors, chain carriers and other assistants. The commissioners report, survey map, field notes and relinquishments were to be delivered to the Governor, and then deposited with the Secretary of State. This was the first act that required right of way relinquishments in writing from each landowner touched by the state road.

Changes made in the 1866 General Statutes declared all previously created state and county roads as public roads and placed them all under the care of the county courts to be "vacated, opened or repaired according to this chapter" [Chapter 52] (*General Statutes*, 1866, p. 289).

Afterward, the general assembly no longer passed laws specific to state roads, and the records were no longer filed with the state.

All records filed with the state prior to 1837 were destroyed in the 1837 capitol fire but copies filed with counties may be available among the loose records of the County Clerk or county road department.

Timeline

Year	Event
1806	<i>An Act concerning public Roads and Highways</i> allowed for inhabitants of a district to petition for public roads within a district, passed July 9, 1806, effective immediately.
1808	The territorial general assembly ordered the first territory wide public road from St. Louis to New Madrid on June 20, 1808, effective immediately.
1814	<i>An Act Concerning Roads and Highways</i> defined public roads and set requirements for the building of the roads, passed January 18, 1814, effective March 1, 1814.
1833	<i>An Act to establish a State road from Columbia, in Boone county, via Rocheport, to Boonville, Cooper county</i> is the first time Commissioners are to submit their records to the Secretary of State instead of the Governor, in addition to the County Courts. Passed February 12, 1833.
1837	Capitol fire destroyed all records filed with the state prior to 1837.
1839	<i>An Act to prescribe the manner of opening State Roads</i> formalized the procedures for opening of state roads, passed February 12, 1839, effective immediately.
1866	Revisions to the <i>General Statutes</i> were passed March 20, 1866, altering the way state roads were created and maintained, placing their care in the hands of the county courts.

Extent: 71.2 cubic ft., (12 Hollinger boxes, 30 oversize boxes).

Arrangement: Alphabetical by beginning point of road. If the beginning point is an individual's residence, it is alphabetical by last name.

Scope and Content

The records for each road can include surveys, commissioners' reports, field notes, relinquishments and oaths. Oaths are most often found with the commissioners' report. Some roads authorized by the legislature, and some documents for each road, may not be extant in this collection.

The various acts of the General Assembly use the word survey, plat and map interchangeably when referencing the drawing of a road. However, "surveys" also is used to refer to all the records collectively.

Some of the surveys are encapsulated and some are stored on rolls due to the length of the survey.

Also contains Commissioners' Report and Field Notes of one levee and one canal.
