Historical and Biographical Notes

Phillip Matthew Donnelly was born in Lebanon, Laclede County on March 6, 1891 to Phillip and Margaret Halloran Donnelly. He graduated from Lebanon High School in 1909. He earned a law degree from St. Louis University and was admitted to the Missouri Bar on December 24, 1912. He then returned to his hometown to practice law with J.W. Farris. He married Juanita McFadden on May 22, 1915 in Maplewood, Missouri. The couple had one son, David.

Donnelly was elected to the Missouri House of Representatives in 1922 as a Democrat, representing Laclede County. He served one term before being elected to the Missouri Senate. He served as a state senator from 1924-1944. He ran for Missouri governor in 1944, defeating Republican Jean Paul Bradshaw and becoming the 41st Missouri governor. Due to Missouri statutes, he could not run for consecutive terms. Donnelly remained active in Democratic politics and ran for governor again in 1952, defeating Republican Howard Elliott to become the 43rd governor of Missouri.

During his first administration, Donnelly dealt with the implementation of the 1945 Missouri Constitution, created the Missouri Department of Revenue, and appointed Frank Park Briggs to fill Harry S. Truman's U.S. Senate seat. He also signed the King-Thompson Anti-Strike legislation and opposed labor organization efforts in the St. Louis Police Department.

During his second administration, Donnelly investigated alleged shortages at the Department of Revenue, added a two-cent cigarette tax to fund education, and secured a \$75 million bond issue to upgrade state facilities. He continued to oppose efforts for unionizing at the St. Louis Police Department and dealt with the 1954 Missouri State Penitentiary riot. He is also responsible for vetoing legislation in 1954 that aimed to demolish the Governor's Mansion.

In 1957, Donnelly returned to Lebanon where he practiced law with his son until he died from a stroke on September 12, 1961. He is interred in Lebanon City Cemetery.

This series contains correspondence pertaining to pardons and paroles. May also include fingerprint records, letters or recommendation, newspaper clippings, prison reports, telegrams and select commutations. Miscellaneous correspondence precedes pardon materials.

Original pardon and parole correspondence on the William Gray case, which began in 1938 with Governor Lloyd Crow Stark, is filed with RG3.43, Records of Phillip Matthew Donnelly, 1953-1957.

Pardons are a power given to the Governor to expunge a conviction. Most cases it is awarded for good behavior after the prisoner has been released, but has been awarded for proven or perceived innocence of the original charge.

Remitter of Bond Forfeiture, 1936-1957

Extent: 11 folders

Scope and Content

Correspondence pertaining to remittance of bond forfeitures comprise this series. Materials may also include applications for remitter and supporting exhibits, court proceedings (abstracts of judgement, court precedents, hearing transcripts, judicial legal opinions, motions to revive judgement, proceedings transcripts), memoranda, notes, newspaper clippings, photocopies, and receipts of bond payment.

Foreign extradition records for Homer H. Davis were removed and refiled in box 6, folder 5. As a result, select folders in this series were renumbered. Original folder number is indicated by parenthesis.

Folder 10 includes correspondence pertaining to Thomas Russell from 1936 to 1955.

The Missouri Revised Statutes (Section 217.805) give power to the governor to grant a remittitur (or remitter) for "any fine imposed by any statute, and for any forfeiture of a recognizance." The latter are surety bonds made for the appearance of accused persons in court; the sureties for the bond are held liable in the amount agreed to by the court if the accused fails to show for trial. The governor must find that by such fine or forfeiture "an injustice [is] done, or great hardship suffered."

According to the statute, applications for relief must include a statement of facts in the case, signed by the judge or prosecuting attorney, and a certificate from the clerk that all costs have been paid. The governor then files his decision in the case, along with the supporting documentation, with the secretary of state.

Waivers of extradition are forms that the offending suspect signs stating that they consent to be voluntarily transferred to another state where there is a warrant for their arrest. The suspect is usually held in custody until they are transferred.
