Historical and Biographical Notes

John Montgomery Dalton was born on November 9, 1900 in Walker, Vernon County to Frederick Andrew and Ida Jane Poage Dalton. The family moved to Columbia in 1914 where Dalton graduated from Columbia High School. He obtained a law degree in 1923 from the University of Missouri and practiced law in Kennett in Dunklin County. Dalton married Geraldine Hall in Senath on November 22, 1925 and the couple raised two children.

Dalton entered politics in 1930 with an unsuccessful campaign for Dunklin County prosecuting attorney. He was appointed marshal of the Missouri Supreme Court in 1931, and served until 1937, when he returned to his law practice in Kennett. Dalton organized four rural electric cooperatives in southeast Missouri. From 1944 to 1953, he served as Kennett city counselor, as legislative counsel for the Missouri Rural Electrification Association, and on numerous local and state Democratic Party committees.

Dalton was elected Missouri Attorney General in 1952, re-elected in 1956, and in 1960 was elected as the 45th governor of Missouri. He was sworn in on January 9, 1961. Dalton instituted tax reform to withhold state income taxes and increased beer, liquor, cigarette, gasoline, and sales taxes. The School Foundation Program for public schools was fully financed for the first time and the State Commission on Higher Education was established. Additionally, Dalton signed legislation which required all passenger vehicles to have seat belts, established a points system for driver's license traffic violations, and oversaw the construction of 294 miles of interstate highway. He secured funding for a new headquarters for the Missouri Highway Patrol and created the Ozark National Scenic Riverways.

Dalton left office on January 11, 1965 and opened a law practice in Jefferson City. He also served on the Boards of Trustees of Stephens College, School of the Ozarks, and Westminster College. Dalton died on July 7, 1972 and is interred in Oak Ridge Cemetery in Kennett.

Domestic Extraditions, 1960-1964

Scope and Content

This series contains extradition materials pertaining to fugitives residing in other states and wanted for crimes committed in Missouri. These records include applications for fugitive requisition, business cards, correspondence, court complaint affidavits and depositions, gubernatorial executive orders, expense claims, receipts, and refusals, formal extradition documents, interdepartmental communications, memoranda, photographs, requests for paperwork corrections, telegrams, telephone messages, thermograph copies, transfer materials from the state hospital, and warrants for arrest. Also contains correspondence from the governors of 18 states.

During a systematic review of Missouri governors' records, material was found that belonged with the records of Governor Dalton. Adding them to the collection required refoldering and re-numbering and an additional box, Box 1A, was added at this time. The original box and folder numbers are indicated within parentheses.

Where joint extradition is asked for two or more fugitives, original filing designation and chronological order is retained. There may not be extradition materials for the entire alphabet (correspondence for Q, X, and Z are rare).

Scope and Content

The series contains extradition materials for individuals residing in Missouri and wanted for crimes committed in other states. Includes applications for fugitive requisition, business cards, correspondence, court complaint affidavits and depositions, gubernatorial executive orders, expense claims, receipts, cancelled checks, and refusals, formal extradition documents, interdepartmental communications, memoranda, photographs, requests for paperwork corrections, telegrams, telephone messages, thermograph copies, transfer materials from the state hospital, and warrants for arrest. Also includes correspondence and supporting materials with governors and/or secretaries of state from 39 states.

Of special interest is an extradition request in 1962 from Governor Terry Sanford of North Carolina for two men wanted for attempting to fix a college basketball game (box 9, folder 10) in Wake Forest, North Carolina.

Where joint extradition is asked for two or more fugitives, original filing designation and chronological order is retained. Extradition cases holding large amounts of material for one individual are filed in a separate folder. When individuals are wanted for extradition by more than one state, chronological order is retained. There may not be extradition materials for the entire alphabet (correspondence for I, Q, X, and Z are rare).
