Governor Christopher Samuel Bond, 1973-1977

Abstract: Records (1973-1977) of Governor Christopher “Kit” Samuel Bond (1939-2025) contain appointments, commutations of sentence, correspondence pertaining to proclamations, county prosecuting attorney’s requests for assistance, domestic extraditions, executive orders, foreign consular registration, foreign extradition correspondence, foreign extraditions, judicial retirement, miscellaneous office management records, news releases, proclamations, election records, restorations of citizenship, special census for Missouri cities, special reports, and waivers of extradition.

Historical and Biographical Notes

Christopher Samuel Bond was born in St. Louis on March 6, 1939 to Arthur Doerr Bond and Elizabeth Green of Mexico, Missouri. He is the grandson of the late A. P. Green, who founded the refractory manufacturing company A. P. Green Industries in Mexico, Missouri. Bond received his college education at Princeton University and his law degree in 1963 from the University of Virginia. He married Carolyn Reid on May 13, 1967 in Lexington, Kentucky. They met in Atlanta, where she was employed as a public-school speech therapist. They divorced in 1995. Bond had one child (Samuel) with Carolyn Reid. Bond married Linda Pell of Kansas City in 2002.

On July 1, 1963, Bond accepted a clerkship with the United States Court of Appeals for the Fifth Circuit in Atlanta, Georgia, and held that position until June 30, 1964. In November 1964 he was employed by Covington and Burling, a law firm in Washington, D.C. He remained with the firm until October 1967 when he returned to Mexico, Missouri to practice law. He unsuccessfully ran for Missouri's Ninth U. S. Congressional District in 1968 as a Republican.

In January 1969 Bond became an assistant attorney general with Attorney General John C. Danforth and served as chief counsel of the Consumer Protection Division, resigning that position in June 1970 to run for State Auditor.

Bond was elected State Auditor on November 4, 1970, and took office on January 12, 1971. He was the twenty-eighth State Auditor of Missouri and at 31 years of age, the youngest person to hold that office up to that time. He was State Auditor when he ran for Governor in 1972.

Christopher (Kit) Bond was sworn in as the forty-seventh Governor of the State of Missouri on January 8, 1973, when he was 33 years of age. At that time, he was the youngest governor in the nation and is the youngest governor in the history of Missouri. Governor Bond was defeated for re-election by Joseph Patrick Teasdale in 1976 but was re-elected governor in 1980.

During the first Bond administration, the governor established a merit system for hiring, secured passage of an open meetings law, and led a petition drive for campaign contributions legislation. Other successes included passage of legislation establishing mandatory sentences for crimes committed with guns and reinstatement of capital punishment for premeditated murder. Bond established the Department of Consumer Affairs, Regulation, and Licensing and created the Office of Public Counsel to represent consumer interests before the Public Service Commission. During his second administration, the governor expanded the Parents as Teachers Program state wide and balanced the budget shortfall from the previous administration.

Bond was elected to the U. S. Senate in 1986. Senator Bond served as chairman of the Senate Small Business Committee from 1995 until 2001. He was re-elected in 1992, 1998, and 2004 but decided against a fifth term. After leaving the Senate in January of

2011, Bond joined the law firm of Thompson Coburn in St. Louis and Washington, D.C. He launched his own firm, Kit Bond Strategies in November 2011. He died on May 13th, 2025 at the age of 86.

Executive Orders, 1973-1976

Extent: .4 cubic feet

Arrangement: Chronological by date of issuance

Scope and Content

This series contains executive orders for the years 1973-1976. Executive orders relate to the constitutional and statutory powers of the governor as chief executive and commander-in-chief of the military forces of the state of Missouri. Although not specifically named in Missouri's constitution, they are believed to derive from Article IV, Section 2, wherein the governor "shall take care that the laws are distributed and faithfully executed." Executive orders have the force of law and are applied and enforced unless overturned by legislative or judicial action.

By executive order, the governor may call out the state guard; declare a state of emergency; bestow military awards; remove officials from office; order guard units to active duty; authorize the destruction of public records (until 1965); promulgate militia rules and regulations; designate state holidays; create agencies, boards, commissions, and councils; and generally, administer government.

The Missouri Revised Statutes (Section 217.805) give power to the governor to grant a remittitur (or remitter) for “any fine imposed by any statute, and for any forfeiture of a recognizance.” The latter are surety bonds made for the appearance of accused persons in court; the sureties for the bond are held liable in the amount agreed to by the court if the accused fails to show for trial. The governor must find that by such fine or forfeiture “an injustice [is] done, or great hardship suffered.”

According to the statute, applications for relief must include a statement of facts in the case, signed by the judge or prosecuting attorney, and a certificate from the clerk that all costs have been paid. The governor then files his decision in the case, along with the supporting documentation, with the secretary of state.
