## Governor Joseph Patrick Teasdale, 1977-1981

Abstract: Records (1966-1981) of Joseph Patrick Teasdale (1936-2014) include accomplishments, boards and commissions, commutations of sentence, departmental and general correspondence, disclosure statements and letters of disclosure, editorials, executive orders, extraditions, federal departments and federal and regional commissions materials, gubernatorial appointments, housing development, inter-office memoranda, inspection reports, invitations and message logs, issue files, judicial case files, legal counsel files, legislative materials, meetings, miscellaneous files, newspaper clippings, news releases, Ozark Regional Commission files, paroles, proclamations, publications, reel to reel tape, restorations of citizenship, speeches, and subject files.

These documents were pulled and interfiled within the correct series in RG3.48, Records of Joseph Patrick Teasdale. Relevant Remitter of Bond Forfeiture series items were removed and transferred to RG3.46, Records of Warren Eastman Hearnes, 1965-1973 and RG3.47, Records of Christopher Samuel Bond, 1973-1977.

# **Historical and Biographical Notes**

Joseph Patrick Teasdale was born on March 29, 1936, in Kansas City, Missouri to William B and Adah Downey Teasdale. He attended Rockhurst High School, Rockhurst University, and the Saint Louis University School of Law. Teasdale was admitted to the 1967. He married Mary Theresa Ferkenhoff on October, 1973 in Conception, Missouri.

Teasdale served as a law clerk for U.S. Court Judge Albert Ridge, United States District Court for the Western District of Missouri. In 1962, he was appointed Assistant U.S. Attorney General in the Western District of Missouri by Robert F. Kennedy where he served as chief of the organized crime section until 1966. Teasdale was elected the youngest prosecuting attorney in Jackson County in November 1966 and reelected in 1968.

He first ran for governor in 1972 but was defeated in the Democratic primary. He earned the nickname "Walkin' Joe" by campaigning across the state on foot. Teasdale defeated incumbent Christopher Bond in the 1976 election. He was sworn in on January 10, 1977 as Missouri's 48<sup>th</sup> governor.

Although his administration was marked early on by a difficult relationship with the press, the relationship gradually improved. Governor Teasdale improved security at the Executive Mansion with the addition of a closed-circuit television system and replaced the use of prison labor on the Mansion grounds with that of Lincoln University students. The governor instituted 'Meet the Governor' sessions in which he and select cabinet members met face to face with voters across the state. Teasdale also refused to accept personal gifts offered during state visits and was the first governor to make his personal income tax returns public.

When the General Assembly could not agree on a site for the construction of a new medium security prison, the governor spearheaded a drive to locate the facility in Pacific, Missouri. He initiated Missouri's first comprehensive energy conservation program; placed nursing homes and insurance companies under closer regulation; and improved the quality of appointments to boards and commissions. With the use of zero-base

budgeting, Governor Teasdale forced departments to provide detailed explanations for fiscal requests and he pruned outdated programs and eliminated unnecessary jobs.

Governor Teasdale was defeated in 1980 for a second term by Christopher Bond. He practiced law in Kansas City until his death on May 8, 2014.

The month folders contain all proclamations signed on days other than official signing day. The governor generally picked one day each month in which most proclamations were signed. Some months have more than one signing day. These records are filed together by signage date (March 11, April 12, May 12, August 11, and etc.).

Supporting documents pertaining to the recognition of General John J. Pershing comprise Folder 5, Box 2. This includes correspondence between Teasdale and other governors, World War I veterans' groups, and the Pershing Memorial Museum Development Fund. John J. Pershing Memorial, located in Pershing Park, Washington, D.C., opened to the public on May 14, 1981.

Out of state proclamation requests are scattered throughout the series. The folders are arranged chronologically by date of request. There are no corresponding proclamations.

Folder 10, Box 3 contains materials pertaining to School Safety Week including letters written by 5<sup>th</sup> grade students to the governor.

Folders 6-9, Box 7 include lists of special days, arranged chronologically by month. Be advised the actual proclamations were issued prior to the designation date. For example, the proclamation declaring International Twins Day September 1, 1978 was issued on April 25<sup>th</sup>, 1978.

Series signatories include presidents Ronald Reagan and Jimmy Carter, Menachem Begin, governors from numerous states, and celebrities Roy Clark, George Gobel, Dolly Parton, Kenny Rogers, and Bud Wilkinson [DJ1][SH2].
