Historical and Biographical Notes

Roy Dean Blunt was born on January 10, 1950 in Niangua, Missouri. He earned a Bachelor of Arts degree in history at Southwest Baptist University and a Master of Arts in history at Southwest Missouri State University. He taught high school history at Marshfield High School.

In 1973, Roy Blunt was appointed county clerk of Greene County. He was elected to the position three times, serving for a total of 12 years. He won the Republican primary for lieutenant governor in 1980 but lost in the general election.

Roy Blunt was elected Secretary of State in 1984 and again in 1988. As Secretary of State, Blunt modernized the securities division by deploying new technology and focused on adding protections for elections. He was also involved with supervising the construction of and moving the office into the State Information Center in 1991, (later named after former Secretary of State James C. Kirkpatrick) and would also help establish the local records program, starting as a part-time operation in 1986 and later being converted into a full-time operation in 1990.

Blunt ran for governor in 1992, and lost the Republican primary to Missouri Attorney General William Webster.

In 1996, Blunt ran for the US House of Representatives in Missouri's 7th congressional district, winning against Ruth Bamberger. He served seven consecutive terms from 1997-2011. In 2010, Blunt ran for the vacant Senate seat, successfully defeating Robin Carnahan. Blunt served two terms from 2011-2023.

Roy Blunt married Roseann Ray in 1967. They have three children: Matthew, Amy, and Andrew. Roy and Roseann divorced in 2002. Roy Blunt then married Abigail Perlman in 2003. The couple has one child: Charlie.

This series contains the correspondence, both incoming and outgoing, of Secretary of State Roy Blunt. Included are items of both an official and a personal nature. Many items are thank-you notes, congratulatory letters, letters of introduction, requests for appointments, etc. The letters cover various aspects of the Secretary's official duties, including the Official Manual, business incorporations, and elections; newspaper clippings accompany some correspondence.

A separate "Thank You Letters" file was maintained from 1985 through 1986. The practice was apparently discontinued; subsequent thank-you notes are filed in their chronological location. Beginning in 1987, a separate "Personnel" file was created; it holds correspondence directly related to personnel of the Secretary's office, such as letters of commendation, resignation, etc.

In addition, a separate grouping of "Election Boards Correspondence" was maintained for Jackson County, Kansas City, St. Louis County, and St. Louis City for the years 1985 through 1988. This grouping is located at the end of the chronological listing of correspondence.

Delegates for the meeting were recruited and selected from the general public.

This series contains information about the planning of Missouri's Jefferson Meeting, which was held in Jefferson City in May 1988. Topics discussed were: amending the Constitution, establishing term limits for the federal judiciary, line item and legislative vetoes, direct election of the President, lengthening terms of U.S. Representatives, initiative and referendum processes, six-year terms for the President, and limiting campaign contributions and expenditures.

Scope and Content

This series contains Newcomb's working papers concerning voter fraud in the St. Louis School Board Elections on April 2, 1991, when two slates of candidates, the "4 KIDS" biracial slate and the "FANS" all-white slate ran against each other for school board seats. An investigation was conducted to respond to allegations of massive vote fraud and to restore public confidence in the St. Louis City election system. The investigation board determined that although some fraud took place, it was not on a massive scale and did not alter the outcome of the election.

In February 1992, the St. Louis Election Board formally asked Secretary Blunt to review the city's registration and voting procedures prior to the April 1992 city elections. This subseries contains papers relating to the investigation of the 1991 elections, as well as information concerning the Secretary of State's Office review of election procedures in 1992.
