Historical and Biographical Notes

James C. Kirkpatrick was born on June 15, 1905 in Braymer, Missouri to Ray and Lena Kirkpatrick. He earned a bachelor's degree from Central Missouri State University in education and then a degree in journalism at the University of Missouri. He married Jessamine Elizabeth Young on August 18, 1927 and had one son with her, Don. He later married Doris Houx, after his first wife passed in 1985. He passed away at age 92 on December 26th, 1997 in Warrensburg, Missouri.

He worked as a newspaper man and held several positions, including editor and publisher, at various newspaper and journal firms throughout his career, including the *Daily Star Journal* (Warrensburg), *News and Tribune* (Jefferson City), *Windsor Review*, and *Daily Democrat* (Lamar).

He served in many positions throughout his life including: a member of the board of regents for Central Missouri State University from 1947-1957, an administrative assistant to Governor Forrest Smith in 1949, member and past president of the Missouri 4-H Foundation Board of Trustees, Missouri Press Association and Democratic Editors Association, and an honorary chairman for the Missouri March of Dimes.

Kirkpatrick first ran for public office in 1960 for Secretary of State. He was defeated by future governor Warren Hearnes. He ran again for the office in 1964 and won, defeating William J. Jones.

Kirkpatrick has the distinction as being the longest serving Secretary of State in Missouri's history. He served five consecutive terms from 1965-1985 and choose to retire after his last term. Some of his accomplishments while in office included state-wide voter registration, overhaul of the election code, administrative rules and regulations of state agencies being published for the first time, updating of the Official Manual, opening of the state's first Records Management and Archives Service, creation of the state's microfilm service, and creation of a central office to make available campaign finance disclosure reports.

Numerous public facilities in Missouri have been named in his honor including the Missouri State Information Center and the main library at the University of Central Missouri.
