WRITS OF ELECTION, 1838-2017

Arrangement: Chronologically by date issued/filed or by date of election

Scope and Content

Writs of election authorize the appropriate authorities to hold elections to fill vacancies (Missouri Constitution, Article III, Section 14) or to vote on constitutional amendments (Article XII, Section 2b). They are issued and signed by the governor and attested to by the secretary of state. The date specified may fall on a primary or general election or may be a special election.

Occasionally, the records include the resignation, expulsion, or notice of death of the vacated official and related correspondence. In the earliest years (1838-1846), these records may supplant the actual writ, though many note that a writ is to be issued. Sometimes it is unclear whether the vacancy was filled by appointment or election.

Records may also include a revocation or withdrawal of the writ, as in 1975, either to issue a new writ or to call off the election entirely. The series also includes several broadsides from county sheriffs announcing the election. For instance, Jackson County for the 14th Senatorial District (1865); Maries County for Judge of Circuit Court (1875); St. Louis County for 2nd Congressional District (1882); and Ralls County for 31st Legislative District (1882).

Writs of election are most often for vacancies in the General Assembly but also for county officials, judges, and elected officials. In 1857, a special election was called for the office of governor after the resignation of Trusten Polk. During the Civil War, many special elections were held for those killed or expelled from office. In 1974, the governor held a special primary election to choose between two Republican candidates who received a tie vote in the primary in Camden County.

Over the years, writs of election have also been issued as proclamations. Some writs of election in this series are, in fact, labeled proclamations. Because of this confusion, writs of election can sometimes also be found in the series *Governor's Proclamations* and, more often, in the closed series *Governor's Proclamations Concerning Elections* (1946-1984).
