Be it resolved by the people of the state of Missouri that the Constitution be amended:

Article IV, Section 54 is amended as follows:

Section 54. Establishes a Missouri Department of the National Guard. — There shall be established a Missouri Department of the National Guard in charge of the adjutant general appointed by and serving at the pleasure of the governor, by and with the advice and consent of the senate, who shall provide for the state militia, uphold the Constitution of the United States, uphold the Constitution of Missouri, protect the constitutional rights and civil liberties of Missourians, and provide other defense and security mechanisms as may be required. To the fullest extent allowed by law, no soldier of the Missouri National Guard shall be deployed for the invasion, occupation, or policing of the Gaza Strip.
