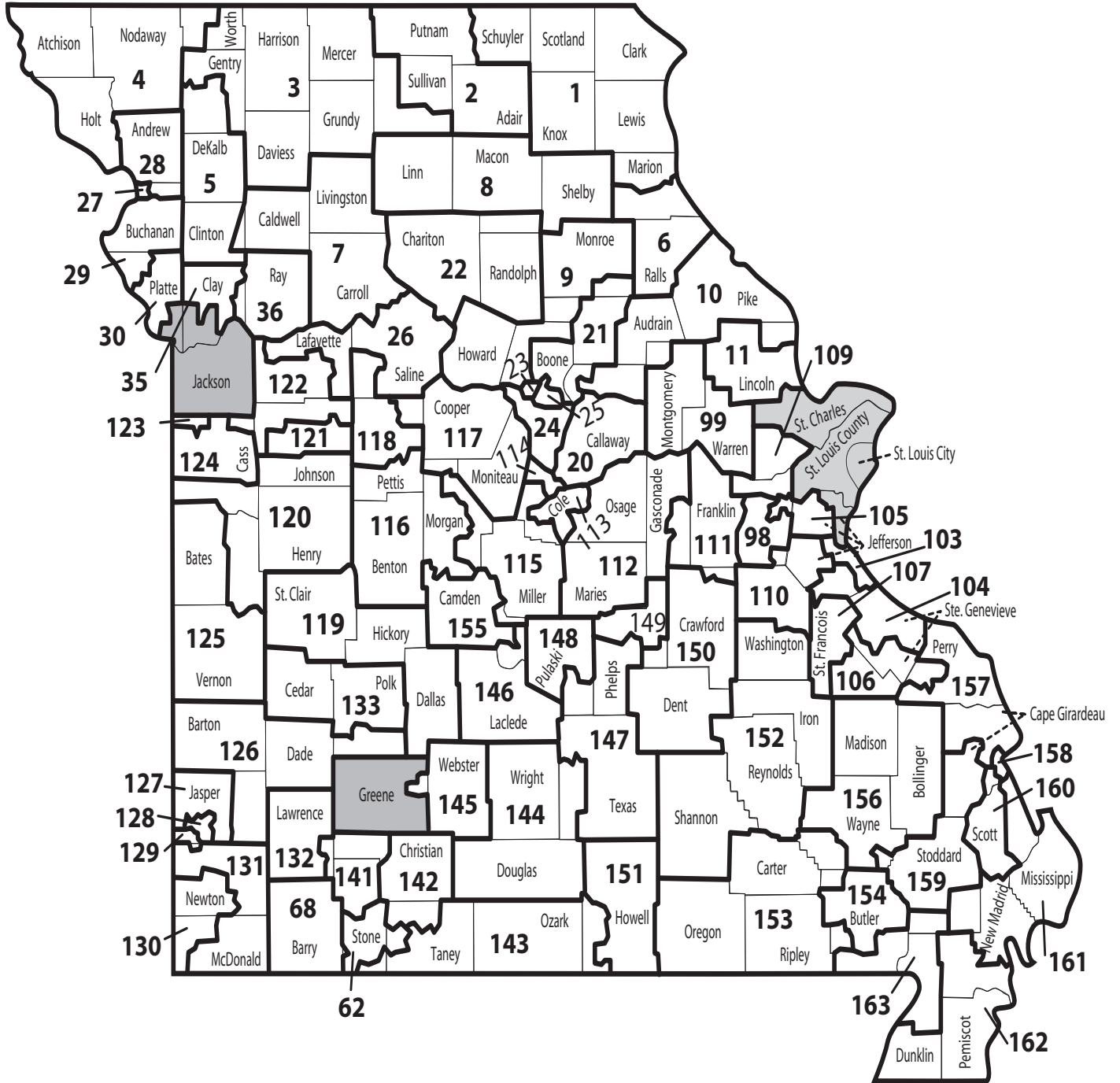
St. Charles County and St. Louis City and County

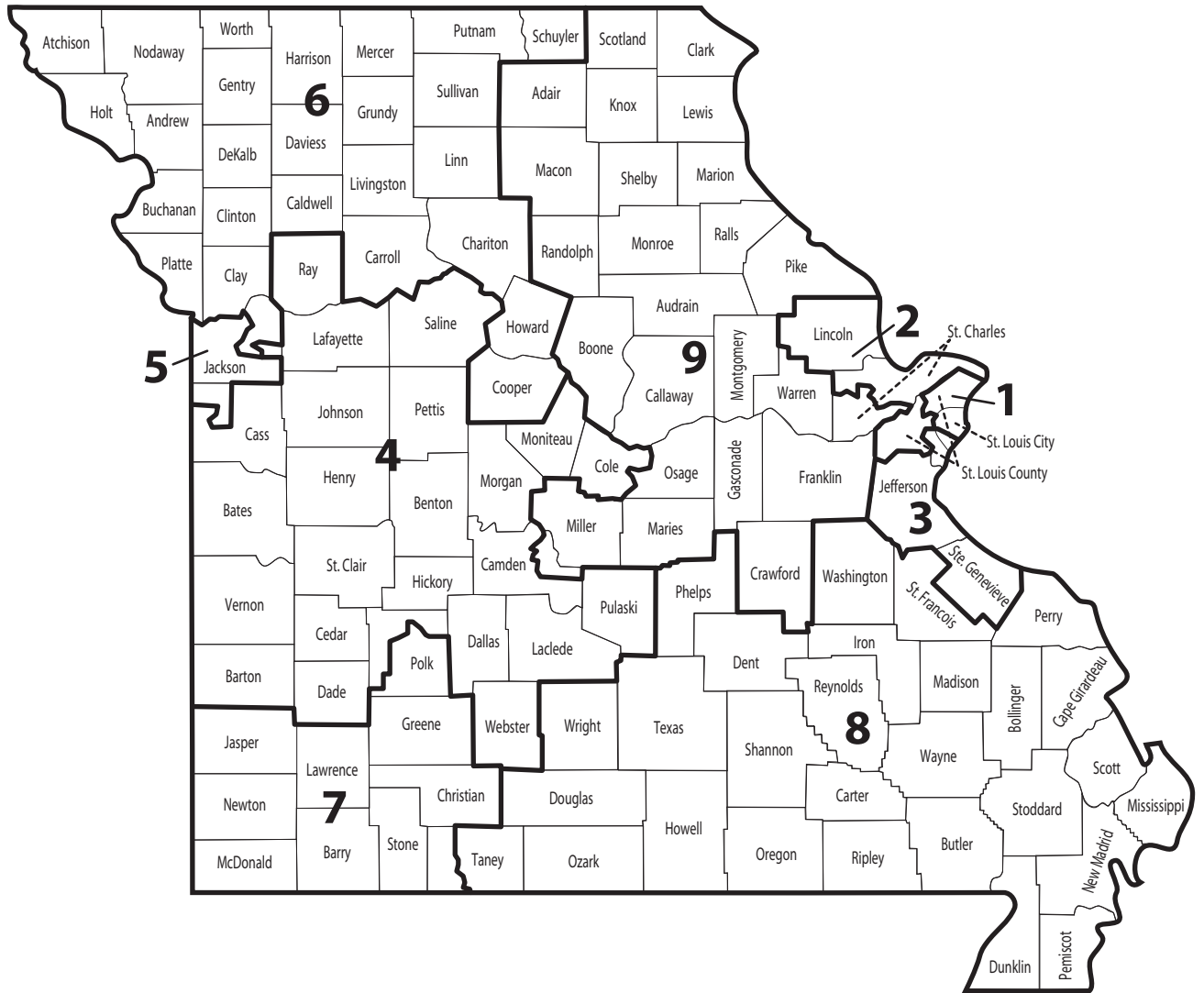

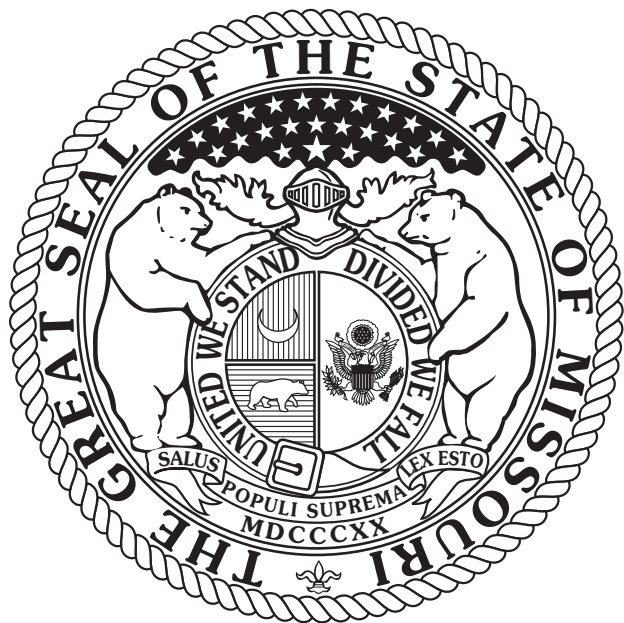
