PURSUANT TO SECTION 37.007. RSMO. THE OFFICE OF THE MISSOURI SECRETARY OF STATE IS NOT PERMITTED TO PAY CONVENIENCE FEES ON CREDIT CARDS, E-CHECKS AND ACH PAYMENTS. DUE TO THIS CHANGE IN MISSOURI LAW BY THE STATE LEGISLATURE, CUSTOMERS THAT MAKE ONLINE AND IN-PERSON PAYMENTS USING THESE METHODS WILL NOW INCUR A SEPARATE CONVENIENCE FEE IN ADDITION TO ANY APPLICABLE FILING FEE.

ALL CONVENIENCE FEES WILL BE PAID TO THE STATEWIDE CONTRACTED PAYMENT PROCESSOR AT THE TIME OF THE TRANSACTION, SO THESE FEES WILL NOT BE ASSESSED, COLLECTED, OR RETAINED BY THE STATE.
